**The following care is provided to all boarding pets.** Please let us know if you have any special requests.

- All pets are housed in individual runs or enclosures suited to their size, health condition and species.
- All pets' quarters are kept clean and sanitary, and bedding is changed daily or as needed to remain clean
- Dogs are exercised outdoors at least twice daily, unless unable to due to medical condition.
- Cats and other pets not taken outside will be offered clean litterboxes or appropriate toilet areas, which will be cleaned daily or more often if soiled.
- All pets are fed daily as requested by their owner, with fresh water available at all times. If no special diet is requested and provided by the owner, we will supply Science Diet Brand or other species appropriate foods.

In order to ensure the health and safety of your pet and all boarding or hospitalized pets, please inform us of any health concerns upon check-in. All pets are required to have had a physical exam by a CPAH DVM within the past 12 months. All pets must be free of internal and external parasites - any parasites discovered while boarding will be treated, at the owner's expense.

All pets must be current on vaccinations, unless approved by a CPAH DVM. Required vaccines are:  
**Dogs:** Rabies, Distemper, Bordatella. **Cats:** Rabies, Distemper and Feline Leukemia (or negative test on file)

If any of these requirements are not met at check-in, CPAH may deny boarding or will perform the appropriate services while your pet is boarding. *Unvaccinated pets will be kept away from the general population.*

***Boarding Consent:***

Como Park Animal Hospital (CPAH) will provide the care detailed above, for the duration agreed above. CPAH veterinarians and staff will take all reasonable precautions against illness, injury, escape and/or death of all pets under their care. CPAH is not liable for health conditions that may develop while the pet is under their care, provided reasonable care and precautions are followed. Any medical conditions, including anxiety related conditions, that may develop while boarding will be treated as deemed appropriate by a CPAH veterinarian. While we will make every attempt to obtain the consent of the owner or an authorized agent before beginning treatment, should an agent not be reached, necessary care will be provided, and costs will be the responsibility of the owner.
